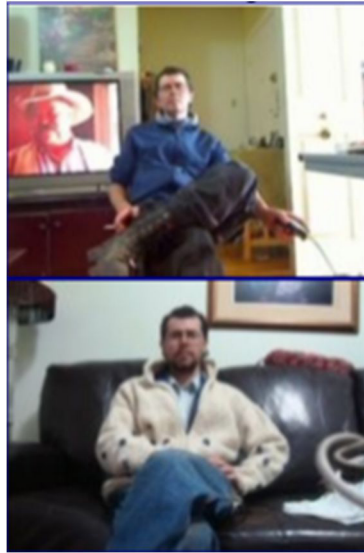

that all that I have been and all that I had is no longer true they destroy the proofs of my innocence and I'm pretty sure I'll soon fall back to a complot where I'll be ul without evidence and without witnesses that they want me to end my life in jail (19:32) And the person I was in 1987 Mario Rockefellerque in 2008 the American judge wanted me condemned saying that the objects I had it was claimed that I was the one who committed his crimes there is no evidence that it was me and that I kept his evidence for accused those who committed it that they tried to say that I had killed a little girl having sex and that the father was in the room for me hypnotized and I had all the proofs of my innocence that I was coming from the united states and I had been hypnotized on the plane and in the airport and the UN to be a pedophile who actually loves children so judges the police falcify documents records for convicted in a complaining of witnesses embarrassing for a government and that all the witnesses of that time many were killed and replaced and replaced by killers (08/0 4/09 6:51) This is my life destroyed by the law and the police and the mafia by smuggling prizes and by plotting conspiracy and lying like the god who walks in a flying saucer that if you want to go to paradise you are welcome end up softening the person I am but he had to go all the way and said jump to the water it will make you less m, al te drown rather than die stabbed and I took my glasses in the hands and I told him I'm going to get away with it because I always get out of it when I get in the water I swam under the water to the other side of the bridge that the water was so cold that I pulled out head of the water and believed that I had been seen if I would have stayed under water maybe I would have cheated them that I spent four hours in the cold water that my brother at the top was trying to save my life and all who was on deck I was trying to convince them to help me that they made me an offer they told me they were a gang and that I needed to have a ganmg to save me that when we are close to death we are ready to do anything to get out of it I say I have friends we are a bit like a gang and told them about the kind of friends I had in Montr that they were anti-violence hippies and that we were not gangs, and they told me that because of them in Montreal, many of their members were arrested and I had already telephoned my brother to two friends and told me that they are professional criminals and that three cars left to kill them all I had to call everyone I knew to tell them that they have no choice and must come help me immediately that they should not call the police but that I told the friend's mother to call the police but she refused and on the bridge came two ckmf animator and asked me what could they do to help me and asked them to make a call to ckmf radio and said on ckmf that everyone who knew Francis Laplante they came to help me and Britney Spears phoned the station to help me as soon as dead that there was that day many have been brought back alive which my daughter and my brother that lived a few days in moose but that this brother had replaced for several years that like twins I frequented my brother who was not always the same persons so I'm going to tell what happened at that moment and after being saved without talking about certain details but that accused of being the culprit a close to me made me kill but did not work that he has deceased and it's not my fault and I have some memory white about what I've been hypnotizing to not remember so how is it possible that in my memory I thought I was the same evening with Britney Spears in his condo in New York but after saving Mario Dumont I took him back to his house near his children in Monmorency near Quebec City: "Before continuing I want to tell you that this winters I would be accused of being one of the gang that has I would have burned alive people just by painting a canvas I wanted to paint the demon and god that was this fall that I had put on you tube images of my toile accompanied by music that I changed my canvas and that the conclusion is that in no case have I been the victim of what some people claim that I did not even remember having had a huge problem with my house and having gone to court since I am accused in a investigation and a conspiracy you will be aware of the same 1992 or have I been retacked by the criminal gangs "and that I passed insecret

court in Magog and also passed for my book only after having won justice on my book it hypnotized me and retried, I had won all my books my texts my book and my photos that you want me to sing with the prison but I will not sing! So let's go back to the story where is my girl who was not supposed to be there was stabbed and brought back to life by me about a year later after buying her sister as a 20-year-old woman I revived her in a 19-year-old woman's body so that they could enjoy their money \$ 20 million for the biggest and \$ 8 million for my smaller one that I had given them and also at the very end of the story of when I was colonel and that the land jumped from the story that I would be the biggest criminal of the earth is wrong that in the details of this story I wanted to prevent a land from being dead unworthily devoured by rats that I was without experience prisoner in a bunker hypnotized repeatedly that I I even tried to save two agents of the cia who were devoured by big monster I will come back to this story tomorrow the 09/04/09 to follow ... 09/04/09 so before retourné as a result of I I want to talk to you about Arab terrorists in Quebec and I was colonel en israel the plot of small bombs throw in the plantations to prevent looting and those who passed after me to cover the full of bombs and I'm not 40 years old and the prison for life I'm because of drafts I dive with the max of dirty drafts and I was treated class of bast so much that I hate but I also know the million people kill in Quebec that behind this white skin hides an Arab

So then I was betrayed and my testimonials were extracted from the judgment and tampered with stealing the people that I was my chance to get justice is thin I'm currently using a camera that I had started to it is directly that this camera is a tool of espionage that the image and voice go directly to a power station and that it modifies the voice enters a second voice that the software arranges a voice live to my tone and the diction of my voice that I participated in the design and production of the ad on the Saint-Hubert rotisserie where we denounce a million dead people in Quebec and do not take me for a child I saw the Arabs kill and take the body of thousands and hundreds of thousands of Quebecers on behalf of Canada and this was before the end of the world that after Magog I was hired to vat and seen so many of my new friends die and be replaced by other friends of biker feder realist Canadian whose Jean Coutu so wonderful man and also Pierre Carl Péladeau that I am a living witness that I would like to talk to you also about Patricia Paquin who was in love with me and other animator who the injustice is never to to speak I had at least five in love the money helped but the love was true the same way that I loved Britney Spears me I have nothing to lose I'll have spent the rest of my life in prison I I do not care the bills in fact are well and truly bikers all those who thought themselves safe by denouncing me so what I need to remember is that there are Arab terrorists in Quebec here that here in the apartment block where I lived that they themselves who have set up a plot and that was and because of them what happened this winters and all this and that the operation that I had is not enough to remove me from justice they told me none of this happened you were it's an operation you'll wake up with a machine in the head a part of the brain in minus. They want me to get paid double so I'll give details I know they want to kill me and I do not care. I am forty years old, there are people who lived from scratch to seventy-nine years old and they died me I did not live from zero to sixty-nine years old I would be eighty years old today: 1920 I remember 1920 so I'm going to talk about what I lived in 2008 I'm going to do everything for I'm going to talk about Canadians all the things Canadians do we are white and white kill each other tremendously for Arabs the richest land masters all over the world and I will admit that I am Arab racist since they were so kind and friends that they have been so treated and thieves of my goods and the deniers of what I have been and that all his white people who had made them trust in them suffered that behind every arabic there is a reason why they are our friends there is nothing for nothing are the thieves of 30 billion American and 11 billions of Quebec dollars that their classy Arabs have

never been killed and their fonts were so bad that they did not stop they arrested plutt those they stole and they deprived us and robbed our army and shouted at the injustice against Quebec in favor of canada who defeated the elite of Quebec and our wealthy Canada are the Americans and the Arabs the killers. So now do not come and tell me that I am powerful and loved because I am helpless and hated.

in 2008 I had an ashtray at Britney spears that I still have today that it had been broken qued I did repair at a welder in the village of Britney Spears one of a decoration is lower than the others here: and in the interminable waits we knitted and this jackets I knitted it in its attententes:

and the glasses I bought in New York in 2005 when I was with Britney Spears

(10/04/09) And here is one of the sofa we had in 2005 at Britney Spears bought in the USA And here was after the drama of autumn 2007 I was lying on the sofa and a peak of 15 feet came out of this place and was an Indian Indian neighbor who saved me

So here I live a little in the past a little hard to confirm because those who lived it and were forgiven either by me or by the justice that they also suffered but also had a brain operation or summers hyp-notized and who died and were brought back to life was hard pressed to hear this story that they have already been dead or criminal, but I have nothing left of my past but a story to write or a lawsuit in door
